2010 Pikes Peak USBC Association Senior Tournament Rules
USBC Certified Tournament

1. **ELIGIBILITY:** To be eligible to bowl in the Pikes Peak USBC Senior Ladies Tournament, an entrant must be at least 55 years of age at the time of participation in the tournament. Bowlers **NEED NOT** belong to a Senior League in order to enter this tournament. All entrants must be members of USBC and the Pikes Peak USBC Association.
2. **ENTRY QUALIFICATION:** Entrants may bowl in more than one team, doubles and singles event by changing (2) bowlers for team and one (1) bowler for doubles. Entrants may enter doubles and singles event only once. Singles will follow doubles. Bowlers may request to bowl singles event at different times, however, both doubles and singles must be bowled. First team, doubles and singles event will count toward All Events.
3. **AVERAGES TO BE USED:** Entrants shall use their highest PIKES PEAK USBC book average for the 2008-09 season. If entrant does not have 2008-09 season average, but has bowled 21 games in 2009 summer league, she may use that average. If a bowler is not able to meet above requirements, she may use highest current average of at least 12 games as of March 13, 2010. All others shall use the assigned average of 200. USBC Rule 319a (2), 10 pins increase provision, will not be used. USBC Rule 319a (3) states it shall be the bowlers responsibility to verify the accuracy of her average, whether originally submitted by the bowler, the team captain or others. Failure to use the correct average shall disqualify score(s) if submitted average is lower, resulting in more handicap. USBC Rules 319d and 319e are not applicable on this entry.
4. **HANDICAP:** Handicap will be 90% of the difference between the bowler's average and 210.
5. **PRIZE RATIO:** There will be 1 prize for each 5 entries in team/doubles/singles/all events. Prize fee will be returned to participants 100%.
6. **ALL EVENTS:** The all events winner will be based on a 9-game total, plus handicap. The all events winner will be awarded a lettered bowling shirt or award of equal value from the Pikes Peak USBC. USBC Rule 307 applies.
7. **TIES:** In event of first place ties in any event, including all events, Co-Champions will be declared, prize money and awards will be divided equally.
8. **SUBSTITUTES:** USBC Rule 324b. If a scheduled entrant is unable to bowl, a qualified substitute will be allowed in the team or doubles event. In case of a disability, after a game has started, a substitute will be allowed, if one is available. Scores bowled through the efforts of more than one individual cannot qualify for all events total. No substitutions can be made in a singles event after the series has started.
9. **ENTRY FEE:** The entry fee breakdown will be:

10. **REFUNDS:** USBC Rule 314: After an entry has been received, and the dates assigned by tournament manager are not refused before preparation of the schedule, the entry fee cannot be refunded.
